Too Many Nebraska Preschoolers Don't Get a High-Quality Education

Federal/State Partnership Needed to Better Serve Young Children and their Families

NEW BRUNSWICK, NJ—The COVID-19 pandemic set back state preschool enrollment and funding across the country, according to the 2020 edition of *The State of Preschool Yearbook* by the National Institute for Early Education Research (NIEER) at the Rutgers Graduate School of Education.

Pre-pandemic, Nebraska saw a small increase in enrollment and inflation-adjusted spending. The state met 7 of 10 minimum standards for high-quality preschool education.

Now is the time for a renewed commitment to high-quality pre-K for all, beginning with those in the lowest income families. Nationally, the report found that:

- Growth in state-funded preschool was slowing before the pandemic.
- The pandemic imposed serious setbacks and reversed recent progress.
- Uneven progress among states is worsening inequality in children's access to high-quality preschool.
- Most states spend too little per child to support high-quality, full-day pre-K and few reach all their 3- and 4-year-olds.

NEBRASKA: 2020 FAST FACTS

Met 7 of 10 quality standards benchmarks. Enrolled 14,361 children, an increase of 404 from 2018-19.

Total state funding was \$27,986,937, an increase of \$2,109,032 from 2018-19 (inflation adjusted).

State spending-per-child was \$1,949 compared to \$1,854 in 2018-19 (inflation adjusted).

Nebraska national rankings:

- 16 in access for 4-year-olds
- 7 in access for 3-year-olds
- 44 in state spending per child

"Funding and enrollment increases are going in the right direction but are progressing too slowly," said Steven Barnett, Ph.D., NIEER's founder and senior co-director. "Now is the time to commit to expanding access and improving quality standards so more children can benefit from preschool."

Nationwide, enrollment in state-funded preschool increased slightly in 2019-2020, but took a hit in 2020-2021 as many programs closed or only offered virtual learning and parents were hesitant to send children to in-person school during the pandemic.

"Nebraska must act now to mitigate the pandemic's impacts on young children and pre-K programs, get pre-K back on track for next year, and recommit to long-term progress," said Barnett. "The federal government should provide support for, and states commit to, high-quality pre-K. While federal rescue and recovery dollars can help, a new federal initiative NIEER has proposed could bring \$46.2 million in federal support to Nebraska for preschool during the next four years."

Across the country the survey reveals bipartisan support for preschool with both "red" and "blue" states among the nation's leaders in high quality pre-K. That offers hope that the nation can move ahead to expand access to high-quality pre-K more rapidly in the future.
