Florida Pre-K Could Look to Neighboring Georgia to Enhance Quality Standards

States looking to address the child care crisis are expanding access to free pre-K for three- and four-year-olds. However, researchers warn that access without quality isn't enough to improve student outcomes. Meanwhile, Georgia Pre-K sets a new example for the nation.

NEW BRUNSWICK, N.J. A new national [report](#) today finds that Florida maintained its ranking of 7th in the nation in providing access to preschool for four-year-olds. In 2024-2025, Florida served 63% of its four-year-olds, far below the state's record high of 80% more than a decade ago. Florida does not offer state-funded preschool for three-year-olds and ranks near bottom in spending per child among all states.

The [National Institute for Early Education Research's 2025 State of Preschool Yearbook](#) presents a critical snapshot of preschool education in America. Currently, 44 states and DC fund preschool programs. Most state pre-K programs continue to primarily or only serve four-year-olds. Nationally, enrollment reached 37% of four-year-olds but only 9% of three-year-olds.

In Florida, the report found that, in the 2024-2025 school year:

- Florida Voluntary Pre-Kindergarten (VPK) enrolled 150,607 children, a decrease of 2,270 from the prior year.
- State spending totaled \$443,714,085, up \$1,860,701 (0.4%), adjusted for inflation, since last year.
- State spending per child equaled \$2,946 in 2024-2025, up \$56 from 2023-2024, adjusted for inflation.
- Florida met 5 of 10 research-based quality standards benchmarks recommended by NIEER.

"When states invest in quality preschool programs that can produce strong outcomes, they invest in a better future for children and taxpayers," **said NIEER director Steve Barnett**. "Florida's longstanding commitment to universal access should be applauded, but providing the quality program the 2002 constitutional amendment specifies requires more funding and higher standards. Florida should look to Georgia as an example of a universal preschool program that meets recommended quality benchmarks."

Nationally, state support for preschool education hit record highs in enrollment and funding in 2024-2025. The pace of growth slowed, however, compared to the prior year, and many states continue to lag behind pre-pandemic enrollment levels.

Georgia's state-funded pre-K program for four-year-olds made history this year. It became the largest state-funded preschool program in the nation to meet all 10 quality benchmarks recommended by NIEER, and the first universal program to do so. Only five additional states meet all 10 of NIEER's research-based benchmarks for quality – Alabama, Hawaii, Michigan, Mississippi, and Rhode Island—in this year's report. None of those programs have the reach of Georgia's Pre-K Program. NIEER's benchmarks measure essential preschool quality indicators, including teacher qualifications, class sizes, early learning standards, and curriculum supports.

"Not only does preschool access vary by which state a child happens to live in, but so does the quality of that preschool experience," **said Allison Friedman-Krauss, lead author of the report**. "Only high-quality early care and education programs support children's development

enough to result in lasting academic and other gains that ultimately deliver savings for taxpayers.”

States spent nearly \$14.4 billion on preschool in 2024-2025. Twenty-eight states increased their investments in preschool from the prior year, for a total increase of \$434 million, or 3%, adjusted for inflation. Including federal and local dollars, total spending was almost \$17.7 billion. Three states each spent more than \$1 billion last year: California (\$4.1 billion), New Jersey (\$1.2 billion), and New York (\$1 billion). Together, these three states account for 45% of all state preschool spending. Texas adds almost another \$1 billion.
