### License Agreement

Rutgers, The State University of New Jersey's National Institute of Early Education Research (NIEER), has developed the Classroom Assessment of Supports for Emergent Bilingual Acquisition (CASEBA) and related training materials.

Rutgers, The State University of New Jersey hereby grants the Licensee a single, non-exclusive, restricted, non-transferable license for the use, performance, display, reproduction and distribution of the CASEBA and NIEER training materials as follows (solely for the purposes of Project as defined in the attached request form attached) on the following terms:

- Rutgers maintains full legal and other proprietary rights to the CASEBA and all NIEER training materials licensed hereunder. This license **does not confer** on Licensee any right of ownership in, or to, the CASEBA and NIEER training materials.
- Licensee will use the materials licensed under this License Agreement only as necessary to carry out Project. In so doing, Licensee will not use the materials in any way that would infringe upon or violate any United States or foreign copyright, patent, trademark, trade secret, or other proprietary right of Rutgers, or of any third party, or any applicable law or regulation. Licensee further agrees not to intentionally use the concepts, CASEBA, and NIEER training materials in any way that would adversely affect the value of said products or Rutgers or NIEER's reputation.
- Licensee acknowledges that it may be acquiring knowledge of trade secrets and/or information of a confidential nature that is of great value to Rutgers. - If the CASEBA and its accompanying materials were to be published, any further use of the instrument should be governed by Rutgers' agreement with the publisher.
- Licensee requests the CASEBA for its use in \_\_\_\_\_ (number) classrooms. The number of classrooms using the instrument will not exceed those stipulated here. For additional classrooms, Licensee will request from Rutgers a modification on this license agreement. Individuals hired and trained to administer the CASEBA under this license are subject to this agreement.
- There is no cost for using these materials, however training is required to administer the CASEBA, and hereby requires a formal budget (templates upon request).

- NIEER has the expectation that Licensee will share with NIEER CASEBA information collected within this agreement, ~~strapped~~ stripped of any identifiable information, that could support the process of validation and reliability of the CASEBA.

Rutgers hereby warrants and represents that it is the owner of the CASEBA and all NIEER training materials licensed to Licensee under this License Agreement, and that the foregoing do not infringe or violate the proprietary and intellectual property rights of any third party.

In addition, there are other conditions that must be met, if NIEER is to agree the Licensee permission to use the CASEBA:

1. Training in administration of the CASEBA has to be conducted by an approved NIEER trainer.
2. Inter-rater reliability of all observers has to be established with anchor observers approved by NIEER.
3. The use of the instrument is limited to the study described including the number of classrooms.
4. A data-sharing agreement must be entered into with Rutgers University so that NIEER can continue studying the validity of the CASEBA.

Licensee agrees to indemnify Rutgers, the State University of New Jersey against any and all claims arising from its use of the materials licensed hereunder except to the extent that Rutgers breached the above warranty.

The license agreement shall be governed by the laws if the State of New Jersey without reference to its conflict of law provisions.
